## SUPPLIER CODE OF CONDUCT

**Entity:** Royals Marine Food Private Limited

**Address:** Pittuvaripalem Village, Pittalavanipalem Mandal, Bapatla District, Andhra Pradesh

### 1. Social Responsibility & Human Rights

Suppliers must uphold the following standards to protect the rights and dignity of their workforce:

- **Legal Labor Compliance (1.3):** Comply with all applicable labour-related laws and regulations and ensure employees are familiar with their rights.
- **Forced Labor (1.4):** Prohibit forced, bonded, compulsory labour, or human trafficking. This includes ensuring no identity documents are withheld and no recruitment fees are charged to workers.
- **Child Protection (1.5):** Prohibit child labour. Young workers (under 18) must only perform non-hazardous work and are prohibited from working at night.
- **Non-Discrimination (1.6):** Ensure equal treatment for all applicants and employees irrespective of gender, race, religion, age, caste, or sexual orientation.
- **Health & Safety (1.7):** Provide a safe work environment, conduct regular risk assessments, and provide necessary Personal Protective Equipment (PPE) free of charge.
- **Freedom of Association (1.8):** Respect the right of employees to join or form workers' organizations and to bargain collectively.
- **Transparent Contracting (1.9):** Ensure all employees receive and understand their employment terms in writing prior to starting work.
- **Fair Wages (1.10):** Pay employees at or above the legal minimum wage at regular intervals and in legal tender.
- **Working Hours (1.11):** Regular hours shall not exceed 8 hours per day and 48 hours per week. Overtime must be voluntary and paid at a premium rate.
- **Disciplinary Practices (1.12):** Apply disciplinary procedures in a progressive and objective manner that respects the dignity and health of the employee.
- **Worker Grievance Mechanisms (1.13):** Provide an effective, confidential, and accessible grievance procedure for employees to report workplace problems without fear of retaliation.
- **Worker Accommodation (1.14):** Ensure any provided dormitory facilities are safe, clean, hygienic, and located separately from production facilities.
- **Community Well-being (1.15):** Proactively engage with local communities to mitigate negative social impacts and ensure access to food and water resources is not restricted.
- **Indigenous Rights (1.16):** Respect the rights, cultures, and traditional territories of Indigenous and tribal peoples.

## 2. Environmental Responsibility

- **Environmental Laws (1.17):** Comply with all applicable environmental-related laws and regulations.
- **Water Stewardship (1.18):** Use water responsibly, identify all water sources, and implement a Water Conservation and Efficiency Plan (WCEP).
- **Waste Management (1.19):** Identify all waste types (hazardous and non-hazardous) and implement a Waste Management Plan (WMP).
- **Effluent Management (1.20):** Identify all effluents and implement an Effluent Management Plan (EMP) to reduce negative impacts on receiving waters.
- **Energy & GHG Monitoring (1.21):** Identify all energy sources, implement an Energy Efficiency Management Plan (EEMP), and report Greenhouse Gas (GHG) emissions.

## 3. Compliance & Transparency Obligations

- **Legal Licenses (1.1):** Possession of all required legal licenses and permits is mandatory.
- **Product Disclosure (3.4.2 & 3.4.3):** Disclose the presence of Genetically Modified Organisms (GMOs) and the inclusion levels of any added antibiotics or medicinal feed additives.
- **Mandatory Declaration (2.1.6):** The ingredient manufacturer must formally declare to Royals Marine Food Private Limited whether they meet this Code of Conduct.
- **Notification of Change (2.1.7):** The manufacturer must inform Royals Marine Food Private Limited immediately of any material changes affecting their compliance.
- **Supply Chain Cascading (2.1.8):** The manufacturer must communicate an equivalent set of requirements to their own suppliers.
- **Right to Terminate (2.1.5):** Royals Marine Food Private Limited will discontinue purchases from any ingredient manufacturer that fails to meet this Code of Conduct.
